Overview

Goal Statement

o Seeking signs of life on Mars: Explore a habitable environment, search for potential biosignatures of past life, collect and document a cache of scientifically compelling samples for eventual return to Earth, and contribute to future human exploration of Mars. By August 5, 2020, NASA will launch the Mars 2020 rover. To enable this launch date, NASA will deliver the instrument payload for spacecraft integration by September 30, 2019.

Challenge

The rover body and other major hardware (such as the cruise stage, aeroshell, and heat shield) will be near-duplicates of the systems of the Mars Science Laboratory (MSL) and will take maximum advantage of engineering heritage. However, the new rover will carry more sophisticated, upgraded hardware and new instruments, such as the highly complex Sampling and Caching Subsystem.

Opportunity

- O Mars 2020 will build upon many discoveries from the Mars Curiosity rover and the two Mars Exploration Rovers, Spirit and Opportunity, by taking the next key steps in our understanding of Mars' potential as a habitat for past or present life.
- The Mars 2020 rover will seek signs of past life on Mars, collect and store a set of samples for potential return to Earth in the future, and test new technology to benefit future robotic and human exploration of Mars.
- The mission will deploy new capabilities developed through investments by NASA's Exploration Research & Technology organization, Human Exploration and Operations Mission Directorate, and contributions from international partners.

Goal Structure & Strategies

The Mars 2020 mission will advance the scientific priorities detailed in the National Academies' Planetary Science Decadal Survey and support payload elements provided by the Human Exploration and Operations Mission Directorate and Exploration Research & Technology organization that are compatible with Science Mission Directorate priorities. Activities to support these efforts in FY 2018-19 include the following:

- The Mars 2020 Project and contributing partners will complete the final design and fabrication phase of implementation (Phase C).
- o The Project will complete the System Integration Review (SIR) and begin Assembly, Test, and Launch Operations (ATLO).
- o The instrument payload will complete development and deliver flight hardware to spacecraft ATLO.
- o The Sampling and Caching System will complete development of the flight model and deliver hardware for system integration and testing.

The Mars 2020 mission progress is reported regularly to the Science Mission Directorate Flight Program Review and the Agency Baseline Performance Review. Mission development is also assessed through standard NASA lifecycle reviews by the Mars 2020 Standing Review Board, as well as the Directorate and Agency Program Management Councils.

Mars 2020 Summary of Progress – FY19 Q4

NASA has completed this priority goal with the delivery of the remaining instruments and is proceeding with integration and testing of the rover, on schedule for launch of the Mars 2020 mission in July 2020.

- o Assembly, Test, and Launch Operations (ATLO) work continues.
 - o The Rover and Descent Stage, stacked in Powered Descent Vehicle configuration, completed electromagnetic compatibility testing, random vibration testing, and separation testing.
 - o The Descent Stage and Rover were de-mated and the Rover was transported to the Environmental Test Lab in preparation for Surface Thermal Testing (STT).
 - o Rover began environmental testing.
 - Sample Caching System (SCS) testbed successfully completed end-to-end testing of sample collection and processing.
 - Final major hardware campaign is completion and installation of Adaptive Caching Assembly Flight Model #2.
- o Heat Shield thermal and acoustic tests complete. The Heat Shield and Backshell are on schedule for shipment to KSC in December 2019
- o The Rover, Cruise Stage, and Descent Stage are on track for February shipment to KSC, where considerable work will remain as the mission team prepares the spacecraft for final assembly and launch.

 Materials may include export-controlled technical information or industrial partner proprietary information, which could not be released publically.

How the Agency Compensates for Data Limitations:

 NASA has not identified any data limitations that would preclude it from reporting accurate, reliable, and timely performance information.
